For the development of scientific and international cooperation FACULTY OF BUSINESS ADMINISTRATION AND ECONOMICS, EUROPEAN UNIVERSITY VIADRINA (FRANKFURT (ODER), GERMANY), PIDSTRYHACH INSTITUTE FOR APPLIED PROBLEMS OF MECHANICS AND MATHEMATICS NATIONAL ACADEMY OF SCIENCES OF UKRAINE (LVIV, UKRAINE) and FACULTY OF APPLIED MATHEMATICS AND INFORMATICS OF IVAN FRANKO LVIV NATIONAL UNIVERSITY (LVIV, UKRAINE) sign this Memorandum of Understanding (MOU) and agree that in support of their mutual interests in the field of research and education will

- 1. Cooperate in the exchange of information relating to their activities in research and teaching in fields of mutual interest.
- 2. Promote appropriate joint research projects and joint study courses with particular emphasis on internationally funded projects.
- 3. Exchange of information about conferences and seminars.
- 4. Jointly organize and conduct scientific seminars and conferences in fields of mutual interest and joint research projects.

- 5. Conduct short courses, cultural projects, study tours, and other activities as mutually agreed in writing between the parties prior to commencement of such activity.
- 6. Involve in study process and research highly qualified specialists from partner institutions.
- 7. Provide an opportunity for internship for academic members of partner institution. In supporting such arrangements, all financial matters, including travel costs, salary payments and other compensations, are subject to individual negotiation, and will normally be the responsibility of the persons involved and their home institution.
- 8. Implement of other cooperative projects and programs on the basis of additional agreement covering all relevant aspects including funding and the obligations to be undertaken by each party, mutually agreed upon, and formalized in writing, prior to the commencement of project or program.

This agreement will take effect from the date of its signing and shall be valid for an unlimited period of time from this date unless terminated, revoked or modified by mutual written agreement between the parties, and may be expanded upon by mutual written agreement.
